Direct Debit Authorisation – Terms and Conditions

In consideration of MM NETWORK SDN BHD agreeing to accept my direct debit authorization for it to debit my credit card, I agreed and confirm that :-

1. There will only be one attempt made for installment deduction from my credit card, MM NETWORK SDN BHD is authorized but not obliged to attempt a subsequent deduction if the earlier one fails.
2. I must inform MM NETWORK SDN BHD in writing of any changes pertaining to the credit card, including new account numbers, termination or cancellation of credit card accounts at least 30 days before the next installment due date.
3. MM NETWORK SDN BHD may at its absolute discretion at any time without prior notice, terminate this authorization without assigning any reason and thereupon shall be under no obligation to debit my credit card for installment payment.
4. This authorization will remain effective for the protection of MM NETWORK SDN BHD notwithstanding my death, incapacity or revocation of this authorization by any other means until written notice of the same is received by MM NETWORK SDN BHD.
5. MM NETWORK SDN BHD is under no obligation to honor any auto debit instructions unless there is sufficient available credit limit in my credit card account at the time the payment is due.
6. MM NETWORK SDN BHD shall not be held responsible or liable for any claims, loss damages costs and / or expenses arising from the successful and unsuccessful processing of the debit due to exceeding credit limit, malfunction of the system, electricity failure and / or other factors beyond the control of MM NETWORK SDN BHD.
7. I hereby agree to indemnify and keep MM NETWORK SDN BHD indemnified against any claims, losses, damages, costs and / or expenses which MM NETWORK SDN BHD may suffer or incur as a result of my authorization to debit the said credit card account.
8. This authorization shall remain binding upon me until MM NETWORK SDN BHD's receipt of my written notification to cancel the authorization. MM NETWORK SDN BHD is entitled to disallow any debit from my credit card upon notice of my death or bankruptcy.
